This is to inform that 23<sup>rd</sup> Annual General Meeting (AGM) of the Company will be held on Tuesday, September 28, 2021 at 11.00 a.m. IST through Video Conferencing / Other Audio Visual means (VC /OAVM), in compliance with applicable circular(s)/notifications issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India, inter-alia, to transact the business set out in the Notice convening the said AGM.

Pursuant to Regulation 42 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and all other applicable, rules, regulations and provisions, please note that Company has fixed Tuesday, September 21, 2021 as the record date for the purpose of payment of Final dividend and Register of Members and Share Transfer Registers shall remain closed from Wednesday, 22<sup>nd</sup> September 2021 to Tuesday, 28<sup>th</sup> September 2021 (both days inclusive) and Dividend shall be subject to approval of the Members of the Company at the ensuing AGM on Tuesday, September 28, 2021.

We would like to inform that earlier we had intimated record date to be 28<sup>th</sup> September 2021, since the register of members would remain closed from Wednesday, 22<sup>nd</sup> September 2021 to Tuesday, 28<sup>th</sup> September 2021 (both days inclusive), however, we have been advised by Registrar and Transfer Agent that since the shareholders would remain same as on 21<sup>st</sup> September 2021 due to closure of book, the record date should be taken as 21<sup>st</sup> September 21 even though the dividend is declared on 28<sup>th</sup> September 21. The same details is hence updated and revised.

The dividend, once approved by the Members at 23<sup>rd</sup> AGM will be paid, subject to TDS, within 30 days from the date of declaration, to those members whose name(s) appear in Company's Register of Members and Register of Beneficial Owners maintained by depositories as on the aforesaid record date. The Integrated Annual Report for FY 2020-21 and Notice of AGM is being sent separately and provided.
